138 ATTEND ARES STORM SPOTTER EDUCATION EVENT

At least 138 people, not including speakers, attended a storm spotter education event Feb. 21 that the Allen County Amateur Radio Emergency Service organized. Speakers included (in order of appearance):

Preliminary results from a web-based survey of attendees indicate that more than half had never attended any kind of storm spotter training previously, despite the fact that more than half were also licensed amateur radio operators. At the time this article was written, nearly

95 percent of respondents described the event overall as either "very good" or "excellent." Just over 92 percent described speakers as "very engaging" or "extremely engaging" and more than 97 percent described the information presented as "very useful" or "extremely useful."

The event also supported a positive image of amateur radio and ARES. Email comments from Homeland Security's Beier reflected this: "My personal respect and

This meeting was in essence a continuation of the equipment auction that was initiated during the January meeting and about fifty items of vintage ham radio gear dating from the 1930's through 70's was offered for auction. These items were from the estate of a ham whose family decided to donate it all to the club.

All but one of the items were of vacuum tube technology and represented many examples of the receiver and transmitter art from Hallicrafter, Lafayette, RME, National Radio Company, Heathkit, Ameco, Eico, Globe Chief, Knight, and a few others, including a beautiful fully functional Collins 32S-1 transmitter.

2019 AUCTION RESULTS

There were 25 attendees who signed in for an identifying number for the February auction.

A total of \$237.50 changed hands as a result of the January auction. The auction benefit to the Fort Wayne Radio Club (as seller #1) was a \$169.50. The club also received \$6.80 in fees from various sellers (the club benefits by 10% of the sales made during the auction). There was a total of \$18.70 in donations to the club. The total benefit from the auction to the club was \$195.00. There were 21 active participants this year (excluding the club), with 2 individual who both sold and purchased items. There were 18 participants who only purchased items, and 1 participant who only sold items. There were 8 auction attendees who just watched. In total, there were 4 sellers at the auction including the club itself.

A total of \$213.00 changed hands as a result of the February auction. The auction benefit to the Fort Wayne Radio Club



appreciation for what you do was significantly increased last night. You are truly cornerstones in the foundation of our severe weather preparedness program. Your personal efforts make Allen County a better-prepared, more-resilient community... you make us Storm Ready!"

As Allen County HamNews reported in previous issues, ARES decided to organize the event after Farlow and Moerhing learned that the National Weather Service (NWS) would be unable to provide spotter training in Fort Wayne before the spring, 2019 storm season. The Northern Indiana NWS office provided, however, much of the content that speakers presented. NWS will present a spotter class in Fort Wayne this autumn and then won't

be able to return to Fort Wayne until the spring of 2021.

Annual Statewide Tornado Drill March 19


The NWS, in collaboration with other agencies, plans a statewide tornado warning drill Tuesday, March 19 at 10:15 a.m. ET. The Allen County SKYWARN net plans to participate by activating and accepting simulated spotter reports. When the drill begins, the net will enter "directed net" mode. We encourage all available hams to check into the net by transmitting their call signs and then one of the words or phrases below, indicated the type of simulated reports they with to make. For example, "Whiskey Nine Lima Whiskey, wall cloud." When acknowledged by the net control station, a reporting station should then make a complete, simulated report in standard TEL (time, event location) format, for example, "At 10:15 a.m., I observed a wall cloud near the intersection of Maplecrest Road and Stellhorn Road in northeastern Fort Wayne. This is a simulated spotter report. W9LW." Below is a list of events from which to choose for simulated reports:

- Tornado
- Funnel cloud
- · Wall cloud
- · Wind damage
- Hail
- · Lightning damage, injury or death

This exercise will provide all participants a chance to practice procedures we would use during an actual severe weather event.

My quest for DXCC and WAZ was mostly done via contesting. Let's face it, there's no better way to work lots and lots of DXCC entities than in DX contests. On CW, that usually involves only copying the DX station's call, your call and an exchange (of which the signal report is usually 599). In summary, I got out of the habit of CW rag chewing like in my Novice and early General days.

But that changed in June of 2011 when I was nominated for The CW Operators' Club (CW Ops, for short). I was nominated by Norm N9MM (a former Hoosier). CW Ops encourages the CW mode, both in rag chewing and in contesting.

Then several years ago I became an

Advisor for the Level 1 CW Academy. It takes students from no code to 15 wpm or so. At the end of Level 1, I make on-theair CW QSOs with my students. Usually this is their first-ever on-the-air HF CW QSO. The QSO usually goes very well, as we've practiced the entire QSO on Skype. After that, the students are turned loose, hopefully to proceed to the next level – Level 2 – and to get on and rag chew to improve their copying ability (invariably their sending is farther along than their copying).

I believe in the saying "if you talk the talk, you better walk the walk." So this got me back into CW rag chewing. I have to admit this isn't a major activity here at K9LA, but I try to make a couple CW rag chews each week. Last week (the week of February 4 thru February 8) was a great example of the joys of a CW rag chew. I called CQ on 40m CW, and was answered by Brian K9VKY in Fombell, Pennsylvania.

After exchanging the customary pleasantries (a real RST, QTH, name, weather and rigs), Brian mentioned that he had lived in Crystal Lake, IL. I told him that I had worked with Motorola in Schaumburg, and had flown into the Crystal Lake airport many times. That got things started. He originally flew for United Airlines out

of O'Hare, but was furloughed and ended up with US Air (before American Airlines bought US Air) based in Pittsburgh (which is why he lives just north of Pittsburgh).

Along the way we also discovered we were both interested in vintage equipment. You can see a small portion of his vintage equipment on his page at www. qrz.com. Remember the January FWDXA column about Marty N9SE building a 1929-vintage transmitter? Well, Brian also built one – see the accompanying photo. Nice job, huh? And I believe the receiver to the right in the photo is a Collins model.

After about an hour, the 40m band dropped out between us. I am sure we would have continued on, but the ionosphere jumped in and said "enough is enough." The message for this month's column is to give conversational CW a shot. You may be pleasantly surprised who you run into.

THE FOXHUNT CHRONICLES FOR FEBRUARY 2019

The last week of January was a real struggle! Temperatures hit near record lows, pipes burst, water mains broke, and the Interstates were littered with semis that had their diesel fuel gel up. Schools missed up to four days. All this bad weather had us all wondering if having our first Fox Hunt of the year on February 3rd was going to be a bad idea! As it turns out, the weather was just great! Temps heading up into the low 50's, and the sun was shining with a gentle breeze blowing.

The 'Fox' team of Linda and Steve, W9LAN & W9SAN, had chosen to hide out on the eastern side of Allen County at Woodlan K-12 school, just to the west of Woodburn.

At 1:30pm the foxes started transmitting. During the first transmission the fox was accidently set to low power. So, although the fox signal was weak at the Cobin Memorial Park start point, the assembled hunters (the team of KC9MUT & KC9EZP, the team of K9OMA, KA9YYI, WB9SSE and ride along hunter Brian Mockenhaupt, and the team of K9LI and his wife Julie plus ride along hunter KD9ITZ) heard it and started heading to the east. Progress was halted for some (more than a half hour for the K9OMA team) by a Norfolk and Southern freight train that came to a halt across several of the grade crossings on roads heading east. (Accusations that the fox team had conspired with N&S engineer Phil Hooper, AB9IZ, to use his company's trains to impede the hunters was later proved to be fake news!)

The day was nice while we were awaiting hunters as we transmitted from our spot at the school parking lot. A sheriff deputy pulled into the parking lot, and for



a while we felt that we might get a visit and a few hundred questions about what we were doing there with a very strange looking antenna on our van, but to our surprise nothing happened! (It is generally felt that there would definitely have been questions asked by the cops if the fox's had been the Pliett/Burke crew, and had it been the Ward/Gengnagel team, the cops would have come out of their vehicle with guns drawn and bazookas at the ready).

After nearly 40 minutes of transmitting on the fox frequency, the first hunter arrived on the scene, and it was Don and wife with new huntress Carla. I offered Carla a tape measure yagi with offset attenuator, and she quickly got the hang of it and started walking in the direction of the athletic fields and the signal from the micro-fox.

Within minutes, the team of Charles, KC9MUT, and Fred, KC9EZP, wheeled into the parking lot. Seems they had better luck with getting around that N&S train than the K9OMA team. Both Charles and Fred quickly deployed hunting gear and they too went off in search of the hidden transmitter. It wasn't too long before

We were just about to dispatch a Search and Rescue team complete with St. Bernards with little whiskey barrels under their necks to find the remaining team. When we did finally contact them on the '76 intercom frequency, they exclaimed they were lost now in Woodburn! We told them to head west to the school area and sure enough, they wheeled in there after a few minutes. Al, WB9SSE, was next to find the fox, followed by caboose Jim, K9OMA. (Apologies for the railroad reference!)

After all the hunters had successfully found the naughty little fox, it was decided to go to the Bob Evans at Chapel Ridge for tall tales and yummy food.
